SPEAKERS

Jerry Rhinehart, CIC, CLU, ChFC, RHU

Jerry is a graduate of the University of West Florida – College of Education. After teaching in high school for a brief time, he moved into the insurance industry. He worked for a P&C direct writer for several years and in 1983 he and his wife opened an independent insurance agency in Tallahassee, FL. Their focus was on life, health and financial services. Additionally, he began working in the Continuing Education field as a speaker and writer. Today Jerry operates Rhinehart & Associates located in Panama City, FL where he works with clients concerning life insurance, longer term care and annuities.

Jerry serves on the National Faculty of the Society of Certified Insurance Counselors. He is Director and Past President of the Tallahassee Chapter of CLU and ChFC. He has served as Director and Secretary/Treasurer of the Professional Insurance Agents of Florida and is a past Agent of the Year for that organization. He is a former member of the Board of Governors of the Society of Insurance Counselors (Austin, TX).

Since 1986 Jerry has conducted more than 1,500 programs to insurance, CPA, attorney and HR groups on topics that range from estate planning, long-term care, life insurance, annuities, business perpetuation and health insurance. He frequently writes articles for various insurance trade magazines and serves as an expert witness in legal proceedings regarding life and health insurance matters.

Patrick began his insurance career in 1969 with USF&G in Louisville, KY. He has been an Underwriting Manager, Sales Manager, Excess & Surplus Lines Underwriter and an Independent Agent. Currently, Patrick is a licensed Risk Manager in Texas. He founded Risk Management and Insurance Education Services in Austin, TX which serves insurance companies, agents and insureds. He holds the Certified Insurance Counselor designation and has been a National Faculty member for the National Alliance for Insurance Education & Education since 1986.

Ray was appointed by Governor Haley to serve as Director for the SC Department of Insurance in November, 2012. With more than 33 years of experience, he received his degree in Insurance from the University of Southern Mississippi and earned his law degree from Atlanta's John Marshall Law School.
